

Subject: OMB's Meeting with Enviros and Clean Energy Group Today
on the Transport Rule

There were two 45-minute meetings today where OMB heard from the Environmental Community and the Clean Energy Group on their views of the Transport Rule Proposal. OMB asked a lot questions to clarify and better understand points each group made. The organizations there, and their main points are summarized below. OMB had a half dozen managers and staff there with Heidi King, our main examiner, running the meetings. OPEI's David Evans and myself listened by phone (only option for us).

Enviros - Representatives were at NEOB and on the phone from NRDC, ED, Earth Justice, Sierra Club, and Clean Air Task Force. They indicated that they had not seen the rule, but had some sense of it. Three main points were: (1) would like to see it proposed soon as possible since that will ensure its first phase in 2012 could happen, (2) see potential for tremendous benefits, especially from SO2 control, and hope that we are being as stringent as we can, and (3) hopeful that the package doesn't make CAIR's mistake of having ancillary actions, like having the new rule equal RACT or BART. They made a strong constructive case for the rule going out now. Did mention that this rule was leading the way for the Utility MACT effort which should have even greater benefits resulting from it.

CEG - Representatives were at NEOB, including Michael Bradley and his staff attorney Carrie Jenks, and company reps from FPL, Entergy, PSEG NJ, Calpine, and Constellation Energy. Noted that they wanted to be supportive of rule that resolved the air emissions transport problem, as many CEG members are in downwind areas and have done a lot to operate cleanly already. Made point that how allowances are awarded for NOx and SO2 matters a lot to them and hopeful that we are moving away from approaches that led to CAIR litigation on fuel factors - which unfairly awarded allowances to relatively high emitters of NOx and provided the wrong incentives - which the Court squarely knocked down. Made pitch for trying to use a creative voluntary allowance trade in approach for the current SO2 bank that Constellation had presented to EPA. After OMB, they made same presentation later today to Joe Goffman and myself. (Can email it to you if you want it.)

Notably, on this Thursday at 3:00, OCIR has arranged for a conference call to discuss OAR's "no federalism implications" determination on the proposed Transport rule. Reps from the National Governors Association (NGA), National Conference of State Legislatures (NCSL) and the Environmental Council of States (ECOS) will participate.

New Sierra Club ad praises Obama for EPA mercury rule

The Sierra Club launched its largest television ad buy in recent history today, saturating the airwaves in Ohio with a spot praising U.S. EPA's new mercury standards for coal- and oil-burning power plants and its effort to halt cross-state air pollution.

The ad also aims to discourage Congress from passing legislation to weaken the standards, which have drawn criticism from power utilities. No individual lawmakers are named.

In the 30-second spot, which will air in the Cleveland, Cincinnati and Columbus markets through Tuesday, viewers are shown images of smoke stacks and children with nebulizer masks.

"With lobbyists and their friends in Congress railing against air pollution standards, it's time to clear the air. The less we have of this, the less she'll have of this," the narrator states, as an image of a young girl with a nebulizer is shown.






### **Miners Prevail in Suit Against EPA**

**News Text:** A federal judge in Washington, D.C., Tuesday threw out tougher water-quality standards issued by the Environmental Protection Agency aimed at curbing environmental damage from surface coal mines in Appalachia.

The ruling by U.S. District Judge Reggie B. Walton was a victory for the mining industry, which has been fighting the Obama administration over a form of mining known as mountaintop removal. The practice involves blasting mountains to extract coal and pushing large quantities of rock and soil into streams.

Last year, the EPA for the first time set limits on the amount of minerals that can be deposited in stream as the result of surface mining in Appalachian states. High levels of some minerals can harm aquatic life.

The National Mining Association opposed the stricter standards and argued in a federal lawsuit that the agency had overstepped its authority by avoiding the federal government formal rule-making process, which requires formal notice and opportunity for public comment.

Judge Walton sided with the industry, writing that the EPA had infringed on the authority granted to states under the Clean Water Act and the Surface Mining Control and Reclamation Act. He said his ruling didn't address how to strike a balance between "the need to preserve the verdant landscape and natural resources of Appalachia and, on the other hand, the economic role that coal mining plays in the region."

The mining association praised the ruling. "Today's decision... has truly given coal miners and coal mining communities their 'day in court' and has affirmed NMA's long-standing belief that EPA overreached its authority in its virtual moratorium on Eastern coal mining permits," the group said.

An EPA spokeswoman said the agency is reviewing the decision.

The ruling follows a separate one in March in which another federal judge said the EPA went too far by trying to revoke a permit for the largest planned surface mine in West Virginia's history, after that permit had already been issued. The EPA has appealed that decision.
