Dear Mr. Horner:

This letter responds to your FOIL request dated February 11, 2014, as modified by our subsequent agreement per my email of March 14, 2014:

*"[A]s promised, I am writing to confirm our agreement of this afternoon to narrow your pending FOIL request (140072) by removing from the criteria listed under '1,' which appears on pages 1 and 2 of your request (viz., 'includes the words and/or acronyms in the Subject field or body'), the following words: 'Coal,' 'Climate,' 'frack (including as 'frack,' or in facked [sic] or fracking),' and 'greenhouse.' These four words appear on pages 1 and 2 of your FOIL request as criteria 'g.', 'h.', 'i.', and 'j.', respectively.*

*"Though still generating a substantial corpus of documents that must be retrieved and individually reviewed, your request, as so modified, will be more manageable. For our part, we have agreed to conduct a rolling production of all responsive documents that are not exempt from disclosure under FOIL. Naturally, as we discussed, your agreement to narrow the request in no way limits your right to make further FOIL requests should you wish to do so.*

*"Many thanks for your courtesy. We will be contacting you again shortly."*

Enclosed is a compact disc (CD) containing documents numbered 140072-1 through 140072-2062, which respond to your request.

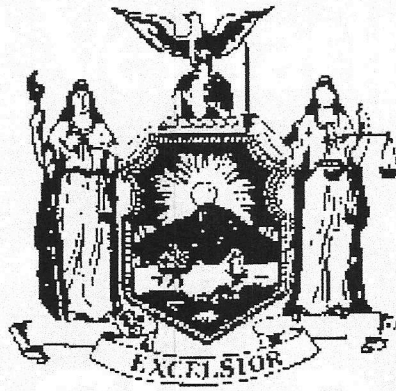
