# 82 Mayors Will Adopt Paris Agreement, Reject Trump Withdrawal

By the end of the day yesterday, 82 mayors representing 39 million people announced that they

will adopt, honor, and uphold the Paris Climate Accord. The list of mayors standing up on this issue is growing.

They write, "We will continue to lead. We are increasing investments in renewable energy and energy efficiency. We will buy and create more demand for electric cars and trucks. We will increase our efforts to cut greenhouse gas emissions, create a clean energy economy, and stand for environmental justice. And if the President wants to break the promises made to our allies enshrined in the historic Paris Agreement, we'll build and strengthen relationships around the world to protect the planet from devastating climate risks. The world cannot wait—and neither will we."

## Governors Announce Formation of U.S. Climate Alliance, Trump Quitting Called "Reckless"

The Governors of New York, Washington, and California have taken a stand against President Trump's quitting the Paris Climate Agreement. New York Governor Andrew Cuomo said yesterday that President Trump walking away "leaves the full responsibility of climate action on states and cities across the nation." Cuomo also said that President Trump's quitting is "reckless" and is an "abdication" of leadership.

California Governor Jerry Brown said, "The President has said climate change is a hoax - I don't believe fighting reality is a good strategy." He says all scientific and world opinion is exact opposite of the hoax terminology used by President Trump. Brown says, "If the President is going to be AWOL in this profoundly human endeavor, then California and other states will step up.

Washington Governor Jay Inslee said, "While the President's actions are a shameful rebuke of the work needed to protect our planet for our children and grandchildren, states have and will continue to step up.

# President Trump Says He Will Renegotiate; France, Italy, and Germany Say No.

One of the confusing aspects of President Trump's position on climate is his continuing to call it a hoax, but he said yesterday he would renegotiate on an issue he's termed as a hoax.

Less than an hour after President Trump quit the Paris Agreement, Italy, France, and Germany issued a joint statement saying the agreement cannot be renegotiated.

"We deem the momentum generated in Paris in December 2015 irreversible and we firmly believe that the Paris Agreement cannot be renegotiated since it is a vital instrument for our planet, societies, and economies."

Paris Mayor Anne Hidalgo said America is making a "dramatic mistake" just two years after playing a key role in securing the deal.

It's important to point out that President Trump calling it quits doesn't necessarily kill the agreement since participation is voluntary, but without America's involvement, the global effort to cut emissions makes it less likely for the nations, except Nicaragua and Syria, to reach its target. Yesterday's reaction to President Trump quitting seemed to reinvigorate more action and energy. Mayors, governors, and big business are not quitters on this issue. Even before Paris in 2015, mayors were "doing" climate, walking the walk, while national leaders were just talking. Mayors around the world joined together to pressure presidents, prime ministers, kings, and queens to get up and stand up and with thousands of mayors agree to something. The mayors of the world stood on the steps of Paris City Hall with Paris Mayor Anne Hidalgo - proud of the national leaders who agreed on the voluntary goals of the Paris Agreement. Based on the reactions to our President's decision yesterday, the efforts to confront climate change will not be diminished because President Trump said we should call it quits.

## Congratulations Mayor Duggan and City of Detroit - Red to Black with \$63 million Surplus.

Not too long ago, Detroit was on the brink of bankruptcy, despair, and even some questioned if one of the greatest cities of America would survive. The figures released from Detroit's comprehensive financial report are great news for Mayor Mike Duggan, the city of Detroit, and the people of Detroit for the auditor's report is letting the world know that Detroit's budget has gone from red to black with a \$63 million surplus.

Detroit has given our nation so much and they will continue as they have in the past with the budget report this week and continued mayoral leadership in Detroit. Congratulations again to Mayor Duggan.

### Oklahoma City Mayor Mick Cornett Announces He's Running for Governor

Our President of The United States Conference of Mayors, Oklahoma City Mayor Mick Cornett announced Wednesday through social media that he will be entering the race to become Oklahoma's next governor.

#### Dear Ron:

Welcome to another installation of my occasional newsletter as Mayor of Charlottesville. (As always, you can unsubscribe at the bottom of this email).

It's been an exciting and busy last few months here. Our most important accomplishment, both in terms of dollars and political will, was to pass a \$171.6 million budget that includes some major new investments.

I frequently say that I believe budgets are moral documents. Our new budget works hard to increase equity and opportunity in C'ville while making investments in a city already frequently rated among the country's best places to live.

Charlottesville is booming. Our population has gone up 12% in 6 years, and commercial assessments went up an average of 30% this year. This created a bounty of tax revenue but a lot of anxiety for property owners, and risks further increasing housing prices and our cost of living.

For those reasons, I was very proud that my colleagues supported my <u>call</u> in my State of the City address to double our contribution to our Affordable Housing Fund. Less successful was my <u>proposal</u> to lessen the impact of our taxes by reduce our real property tax rate from 95 cents to 93 cents, which was not supported by Council.

Our budget also invested an additional \$2 million in our public schools, increased our public safety salaries by over \$500,000, established a living wage for all City employees, invested millions of capital dollars in major infrastructure projects such as the West Main streetscape corridor connecting the Corner and the Downtown Mall, our new strategic parking plan, and a new Belmont Bridge, and puts \$2.5 million toward the redevelopment of public housing.

We also added over \$100,000 to our overall support for nonprofit partners like the <u>Community Investment Collaborative</u>, <u>African-American Teaching Fellows</u>, the <u>Charlottesville Free Clinic</u>, the <u>Thomas Jefferson Coalition for the Homeless</u>, the <u>Boys and Girls Club</u>, and the <u>Sexual Assault Resource Agency</u>.

There have been other major accomplishments in recent weeks. I was very proud to lead a successful effort to cut taxes for small businesses earning between \$50,000 and \$100,000 in the City, by changing the license charge from a rate charged against gross income to a simple \$50 fee, saving 450 businesses hundreds of dollars a year.

Following on my promise at the <u>Capital of Resistance press conference in January</u> to drive action on immigration in our City, we unanimously passed a <u>new policy</u> setting forth the principles that will guide us on immigration issues.

We explained that our limited resources should be dedicated to local and state law enforcement, and made clear that we stand with our law enforcement professionals who all believe our limited and welcoming approach builds the bridges within our community necessary to maintaining public safety.

We also created and funded two important new programs -- a \$10,000 allocation to the Legal Aid Justice Center to provide Know Your Rights trainings, education programs for immigrants and their families, and litigation support for detainees, and a resource brochure to be widely distributed through the community.

Another major step forward was our <u>passage</u> of a multi-faceted agreement to develop the blighted Landmark Hotel that has loomed for several years on our Downtown Mall--a major promise of my campaign for City Council. The agreement includes tax abatements and parking incentives and will bring a 5-star hotel and several related businesses to our key commercial sector, with an estimated \$8-9 of tax revenue earned for each \$1 invested by the City,

On the controversial issue of our Confederate statues, we also unanimously moved forward a \$1 million plan to add new monuments to recontextualize both our Robert E. Lee and Stonewall Jackson parks in a "precinct" concept Downtown.

There was also a divided 3-2 vote to remove the Robert E. Lee statue, which I voted against, explaining, "I worry about the impulse to remove, delete, and expunge that which offends us... That we must see and defy these monuments to overcome what they mean." You can read my full speech <a href="here">here</a>.

Finally, in a continuing effort to make our governance as efficient, engaged, and effective as possible, we affirmed our support for the new governing procedures we passed a little over a year ago, while adding 25% more public comment slots than in decades past.

Along the way, C-SPAN's American Cities tour visited our fair city and was kind enough to interview me both in a BookTV segment about my book <u>Becoming Madison</u> and a piece about the <u>Capital of the Resistance</u>.

Meanwhile, we supported the <u>Tom-Tom Founders Festival</u> with a \$25,000 donation, which in turn brought tens of thousands of visitors to Charlottesville for an extended celebration of innovation, art, creativity, music. I was pleased to appear in the festival's opening event, where I

presented a mayoral proclamation <u>celebrating</u> Tom-Tom's branding of Charlottesville as "America's Founding City,"

Finally, I was honored to appear at UVA's Batten School of Leadership and Public Policy with famed chef Alice Waters and Rosa Atkins, our Superintendent of Schools, to announce a weeklong Farm to Schools and Healthy Schools Week this October, where we'll serve healthy and locally-sourced school lunches -- an initiative I <u>developed</u> after first meeting Alice here last summer.
